The proposed tax rates are \$.0937 per \$100 of assessed real estate and \$.16 per \$100 of a assessed personal property.

This represents a \$.0063 decrease per \$100 of assessed real estate tax rates and no change in personal property tax rates.

Water and sewer rates will be increased by \$5 per billing cycle (two months) for in town residential, by \$10 per cycle for commercial accounts; increase per-cycle overage rates by 6% on all accounts types and increase the per cycle minimum from 5,000 gallons to 6,000 gallons effective with July 1, 2019 billing and thereafter.
