2018 Personal Property Tax Bill

SPECIAL MESSAGE

Your tax bill has been reduced by 70% on the first \$20,000 of the value for your qualifying vehicle. If your qualifying vehicle's value is \$1,000 or less, your tax has been eliminated and the Commonwealth's share is 100%. Tax relief was calculated using the tax rate that was in effect on August 1, 1997.

Payments postmarked by due date will be considered timely. Late payment penalty of 10% on assessed tax after December 5, 2018. 8% interest begins 7/1/19. Assessments Commissioner of Revenue

A DMV stop will be placed beginning 3/1/2019. If you have delinquent taxes and a DMV stop has been placed on your account, all past due taxes must be paid with cash, cashier's check or money order to remove the DMV stop. Please call to obtain current amount due.
