2021Town of Kilmarnock Photo Contest Official Contest Rules

Eligibility

Open to legal residents of the continental U.S., 18 and over. Employees (and their immediate families) of the Town of Kilmarnock, their subsidiaries, vendors, media partners and advertising agencies are not eligible. Void where prohibited. Federal, state, and local laws and regulations apply.

Entry

All entries must be received between March 1st, 2021 and August 31st, 2021 ("Entry Period"). All photo entries ("Submissions") must be family friendly, taken in the Town of Kilmarnock and comply with these official rules. NO physical bodies/persons or pictures of humans may be in pictures. Animals, nature, scenic etc, are ok.

Submissions will not be publicly displayed during the entry period, however, photos will be displayed and used by the Town of Kilmarnock in marketing campaigns, social media sites, and the Town of Kilmarnock website as articulated herein.

For this reason, you, as the entrant, must warrant:

i. that your Submission does not infringe on the intellectual property (copyright, trademark, patent) rights of any third party rights holder, or feature artwork created by another person; and

ii. that any copyright holder of the Submission has granted you permission to participate in this Contest and has granted, or will grant, to Sponsor and its Agents the right to publish a winning Submission as articulated in these rules; and

There are three means of entry. The maximum number of entries is 5.

You must own the copyright to any photo submitted and we request that you familiarize yourself with the Release paragraph included in these rules. All photos must be in .jpg format and must be a minimum of 5MP in size. You must own the copyright to any photo submitted and we request that you familiarize yourself with the Release paragraph included in these rules.

A third party will judge all entries. No Town staff or affiliate will have jurisdiction over the winning photos.
